OVERVIEW

Regrettably we are not able to offer this guarantee on any items which have been purchased in a sale or clearance promotion, nor on foodstuffs/confectionary or personalised items, unless faulty. This does not affect your statutory rights.

You must return the products at your own cost. You are responsible for the returned items until they are received at our address so we recommend you obtain a Proof of Postage Certificate which you can get from the Post Office as we won't be able to process your refund until we are in receipt of the goods. Please note that refunds may take up to 10 working days to process.

*Please note that this period is automatically extended over the Christmas period. Any gifts purchased between mid-November and 24th December every year can be returned up until the following 14th January, but please contact us before you do so.
